The Public Funds Investment Act, Chapter 2256.023 of the Government Code requires the investment officers of each local government to submit to its governing body a quarterly report of investment activity, performance and disclosure. The Denver City Investment Policy established three pooled funds. An operating fund, a bond fund and a special purpose fund. By a resolution passed December 4, 2023, the City Council designated \$2,000,000 to be held as a reserve for operations and \$300,000 be kept in a checking account and available for daily operations. The bond fund segregates funds that will be used to meet the principal and interest payments on any bond issue that is an obligation of the City. The remaining cash was designated for long term capital improvements, projects and development. The Investment Policy stipulates that operating funds be kept in investments that ensure safety of principal and liquidity. The bond fund investment strategy requires safety of principal and liquidity to meet debt service payments. The special purpose fund requires safety of principal and staggered maturities for flexibility to meet cash demands. All investments are accounted for and reported following generally accepted accounting principles, the Public Funds Investment Act of the State of Texas and the Investment Policy of the City of Denver City.
